

FOR OFFICIAL USE ONLY (FOUO) 635 SCOW WRM GMO Indirect Mission Support Request (IMSR) Routing Form



IMSR Release Authority:

- Less than 60 days, Wing WRM Program Manager (WRMPM) approval (On installation only)
- 60-120 days, (< 60 days if assets leaving installation) Command WRMO (CWRMO) approval
- Greater than 120 days, or if CWRMO cannot source within own theater, WRM GMO approval
- Foreign Nation or Sister Service, HAF approval

All items released for IMSR support must be available for recall within 24 hours if required for contingency/wartime (Direct Mission Support) use.

IMSR requests submitted to the WRM GMO will be consistent with the following:

1. All WRM use requests will be documented by the requester (WRMO/CWRMO) on the SIPR/NIPR WRM Usage Log located on the GMO SIPR/NIPR SharePoint. WRM usage requests include, but are not limited to, exercises, Humanitarian Relief Operations, and POTUS support requirements.

2. In turn, requests will flow from the requesting organization to the applicable CRWMO for approval. Once approved, the CWRMO will submit requests to the 635 SCOW WRM GMO for consideration.

3. Upon approval by the 635 SCOWWRM GMO, the user is responsible for all associate usage costs, to include, but not limited to: packing, crating, transportation to and from the employment site, TDY costs for personnel deploying with the assets, contractor costs as applicable, maintenance and reconstitution/repair of assets, MRSP costs, etc. Note: Any maintenance beyond the capability of the using organization must be identified to the Storing Command. The storing Command may assist in identifying alternatives to obtain the necessary support.

4. The requesting organization, U.S, DoD activity will provide a Funds Assurance Letter; foreign nation support requests will use a CC Form 35 Acquisition and Cross-Servicing Agreement (ACSA), prior to approval or release of assets by 635 SCOW WRM GMO. DD Form 448 Military Interdepartmental Purchase Request (MIPR) will only be required if actual costs are incurred.

5. Initial funding amounts are based upon the following parameters:

- a. 10 percent of total asset cost
- b. Recurring exercises/deployments may use historical costs with 635 SCOW/GMO pre-approval

6. Using CWRMO will coordinate with the 635 SCOW WRM GMO on the reconstitution procedures of BEAR, FSE, and EAGLE support equipment prior to redeployment.

7. The storing organization representative, in conjunction with the using organization custodian, must document the return of the WRM, and identify the status of each asset in accordance with the published interim guidance.

8. An estimated repair completion date will be provided, and status tracked for any asset not fully mission capable upon return to storage.

9. Once all WRM assets are returned to the appropriate storage location, reconstituted and are in deployable status; storage unit will submit the 635 WRM GMO IMSR reconstitution letter (via the WRM GMO SharePoint) to the 635 SCOW WRM GMO and other agencies included in the original request message. This dollar amount will then be billed to the line of accounting submitted via the MIPR/ACSA.

10. The storing command will provide the WRM GMO receipts and documentation, upon request, for all repairs and /or reconstitution costs of the UTC or items deployed.
