INSTRUCTIONS

JOIN SPOUSE NO DEPENDENT- CSP APPLICATION

The primary benefit of this program is to enable join spouse couples without dependents serving concurrent tours in Korea accompanied tour entitlements and the same housing priority category. Only Join Spouse (Military-to-Military) with no dependents in DEERs or otherwise, may apply for the Joint Spouse No dependent CSP (JSND-CSP) program. To be considered eligible, BOTH join spouse military service members must have a projected assignment to an accompanied tour eligible installation (i.e., Osan AB and Camp Humphreys). If approved, both service members must agree to elect to serve the full accompanied tour length of 24 months, however only one service member of the join spouse household will be entitled to the full accompanied PCS entitlements.

In the unforeseen event either service member acquires a dependent while serving under the JSND-CSP program, both service member would automatically become disqualified from the JSND-CSP program and must immediately apply for a traditional Command Sponsorship Program with either service members CSP manager. JSND-CSP is strictly for couples without dependents since JSND-CSP does not offer any entitlement coverage needed to support dependents. This would be the same process for unaccompanied personnel serving in Korea that acquires a dependent during the middle their tenure in Korea at an accompanied authorized installation such as Osan AB or Camp Humphreys. However, the added benefit in transferring to a traditional CSP from a JSND-CSP billet would be to not incur any additional retainability nor impact your current DEROS since you are already enrolled in serving the accompanied tour length. Lastly, JSND-CSP participants that are disqualified must contact 51 FSS/FSPD CSP program manager at (51FSS.fsmpd.csp@us.af.mil) to indicate their disqualification due to an acquired a dependent no later than 30 days from the change in status.
